

# **NOTICE OF FUNDING OPPORTUNITY**

## **Call for Projects for Lake Area Foundation, Inc. Grant Funding**

The Lake Area Foundation, Inc. would like to announce an upcoming opportunity to apply for grant funding from the Lake Cumberland Area Development Fund (LCADF).

### **About the RCDF:**

Using income derived from discretionary endowments, the LCADF seeks to award grant funding to address the most pressing needs and to support the most promising opportunities for community benefit and economic development in projects that benefit the Lake Cumberland region of Adair, Casey, Clinton, Cumberland, Green, McCreary, Pulaski, Russell, Taylor, and Wayne Counties.

### **Grant Award:**

Applicants may request up to \$5,000. However, smaller requests will receive extra points during scoring. Grant awards are made on a one-time basis and requests for multi-year funding will be denied. Lastly, the LAF may choose to make partial awards at its discretion.

### **Match Requirement:**

Applicants must provide matching funds at a minimum of 20% of the grant amount requested from the LAF. However, matches in excess of 20% will receive additional points during scoring.

Acceptable match types include cash from the applicant or funds from another funding source going towards the same project. In-kind matches will not be considered to fulfill this requirement.

**Deadline to Apply:**                      October 31<sup>st</sup>, 2025 by 4:00 PM Central.

**Award(s) Announced:**                      Mid-November 2025.

**Eligibility:**

- Project must serve and provide community and/or economic development benefit to Adair, Casey, Clinton, Cumberland, Green, McCreary, Pulaski, Russell, Taylor, and/or Wayne Counties in Kentucky.
- Project must have a significant and demonstrable positive impact upon the community and/or economy **OR** otherwise support the needs of a non-profit organization or entity that serves the community such as food banks, volunteer firefighters, etc.
- Eligible applicants include...
  - (A) Public institutions, schools, local governments and their subsidiaries.
  - (B) Organizations with an active IRS 501(c)(3) non-profit designation.
  - (C) Private, for-profit businesses **ONLY IF** the project will have a positive community and/or economic benefit.
    - Organizations that qualify under either (A) or (B) will receive an extra five (5) points during scoring of applications.

Completed applications must be in LAF's possession by 4:00 P.M. Central on October 31<sup>st</sup>, 2025. It is the applicant's responsibility to ensure that any applications delivered by mail or courier service arrive by this date as post-marked applications arriving after this deadline will NOT be accepted.
